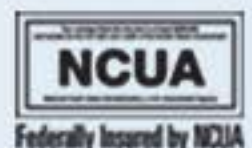

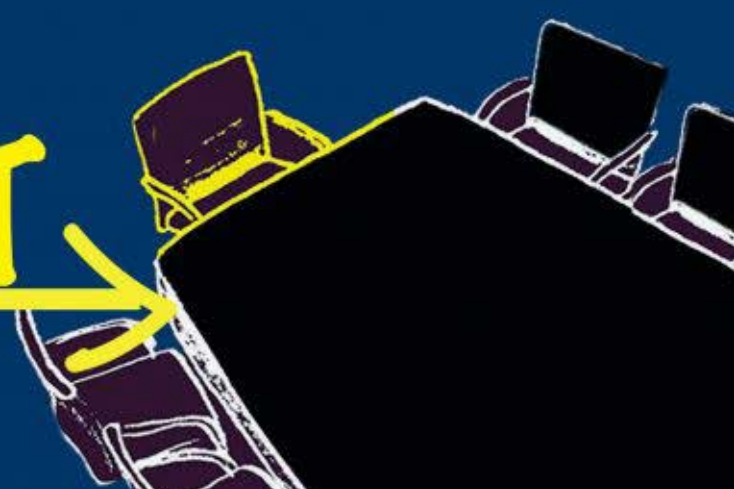

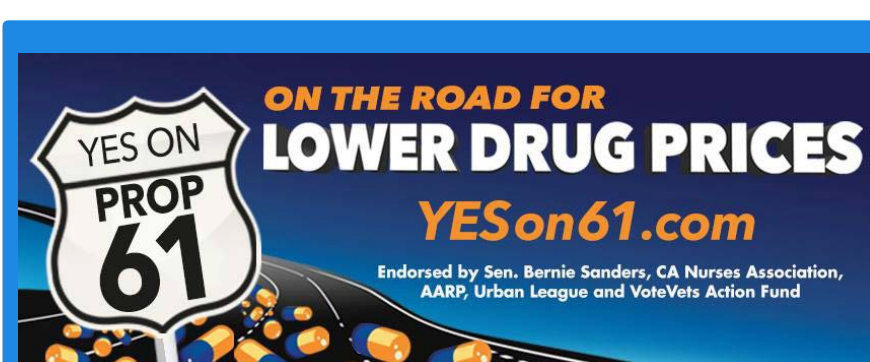

Gear Up for Grammys 2016

More than 21,000 entries submitted to The Recording Academy® for 59th GRAMMY Awards® Consideration; Nominations to be Announced Dec. 6



The Awards process for the 59th Annual GRAMMY Awards® is well underway with 21,719 entries received by The Recording Academy® for GRAMMY® consideration. This total marks an increase from last year's 21,564 submissions.

Congratulations to the many AFM Local 47 members who created and performed on nominated recordings!

All entries were due Aug. 24 and have since undergone a vetting process to verify eligibility in preparation for first-round ballots, which were mailed to Academy Voting members on Oct. 14. As part of that process, The Recording Academy convened 350 artists and experts to listen to and organize the thousands of entries into one of The Academy's 84 Awards categories in 30 Fields.

Earlier this year, The Recording Academy announced amendments to the rules governing the GRAMMY Awards. Key changes included refinements to the guidelines around Best New Artist, Blues, and Rap categories, a move to make streaming-only releases eligible for GRAMMY Award consideration, and limits to the number of categories in which Recording Academy members may vote. The eligibility period for the 59th Annual GRAMMY Awards is Oct. 1, 2015 through Sept. 30, 2016. Below are additional key dates and deadlines:

Nov. 15, 2016: Last day for Voting members to join and receive the final ballot

Dec. 6, 2016: 59th GRAMMY nominations announcement

Jan. 13, 2017: Final ballots due

Feb. 12, 2017: 59th Annual GRAMMY Awards

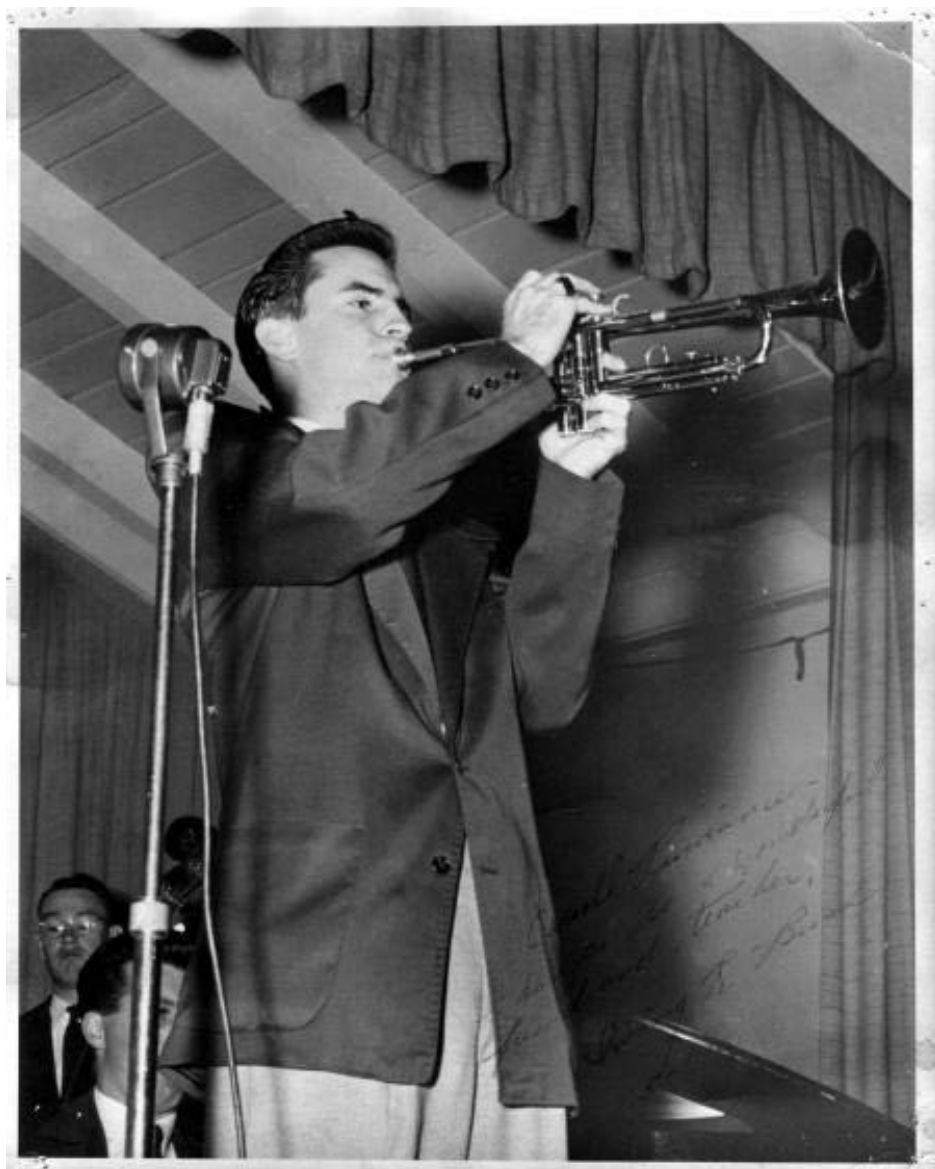

About Irving R. Bush

Mr. Bush was born in L.A. and at age 16 joined Local 47. He received his BA and MA at Cal State University Los Angeles. His career encompassed playing with top name big bands, studio work, motion picture dates, and record dates. For years he enjoyed being Nat King Cole's personal lead trumpet player. In 1962 "Irv" joined the LA Philharmonic as Associate Principal Trumpet. He designed a line of mouthpieces for trumpet, cornet, flugelhorn and piccolo and still found time to write a book titled "Artistic Trumpet Technique and Study" (revised in 1995 as "Trumpet Players Blow With Good Vibrations"). He was a design consultant for Benge Trumpet located in Burbank and The Olds Company – Trumpet Division. He taught trumpet at Cal State LA and USC. Throughout his entire musical career he remained a dedicated and active member of the Musicians Union Local 47.

AFM Musicians Support SAG-AFTRA Video Game Strikers

AFM members joined more than 100 on a picket line in Playa Vista today support of SAG-AFTRA interactive video game voice actors who have been on strike since Oct. 21.

As reported by [Variety](#):

“The performers union launched the strike against EA and 10 other videogame makers after negotiations cratered over the key issues of secondary compensation (residuals) and transparency — meaning that the union wants companies to stop being able to hire without identifying the game. Carteris noted that the talks lasted 19 months before collapsing.”

The strike order reads as follows: “The National Board of Directors instructs all SAG-AFTRA members to withhold performing services and auditioning for work under the Interactive Media Agreement with respect to struck games for the following struck employers effective midnight of Oct. 21, 2016.”

Alf Clausen's 30 Emmy nominations and two Emmy Awards recognize his longevity and creative work on numerous television series and Movies of the Week, with emphasis on *The Simpsons*, for which he has composed for 27 years, plus his credits on *Moonlighting*, *Bette*, *ALF*, *Fame*, and *Murder in Three Acts*, among others. Feature film credits include *Half-Baked* and *Number One with a Bullet*, plus additional music and orchestrations for *Airplane II: The Sequel*, *The Beastmaster*, *Mr. Mom*, *Naked Gun* and *Splash*. Alf served as musical director, and composer/arranger for *The Donny and Marie Show*, *Mary*, and *The Mary Tyler Moore Variety Hour*, plus numerous performing artists. He has multiple CD credits (as songwriter, conductor and producer), including *The Simpsons: Songs in the Key of Springfield*, and his Alf Clausen Jazz Orchestra CD, *Swing Can Really Hang You Up the Most*.

William Ross is a respected and award-winning composer/arranger whose work has spanned feature films, records, and television. He composed music for such films as *The Tale of Despereaux*, *Ladder 49*, *The Game of Their Lives*, *Tuck Everlasting*, *The Young Black Stallion*, and *My Dog Skip*. His work in television includes the critically acclaimed miniseries, *Life with Judy Garland: Me and My Shadows*, and the Emmy-winning music for the *Tiny Toon Adventures*' episode, *Fields of Honey*. Ross has arranged music for a stellar roster of artists including Barbra Streisand, Celine Dion, Josh Groban, Andrea Bocelli, Michael Bublé, Kenny G, Quincy Jones, David Foster, and Mariah Carey. In addition, he has served as music director for many historic events and conducted four Streisand concert tours (2000, 2006, 2007 and 2012) as well as four Academy Awards presentations (2007, 2011, 2013, 2014).

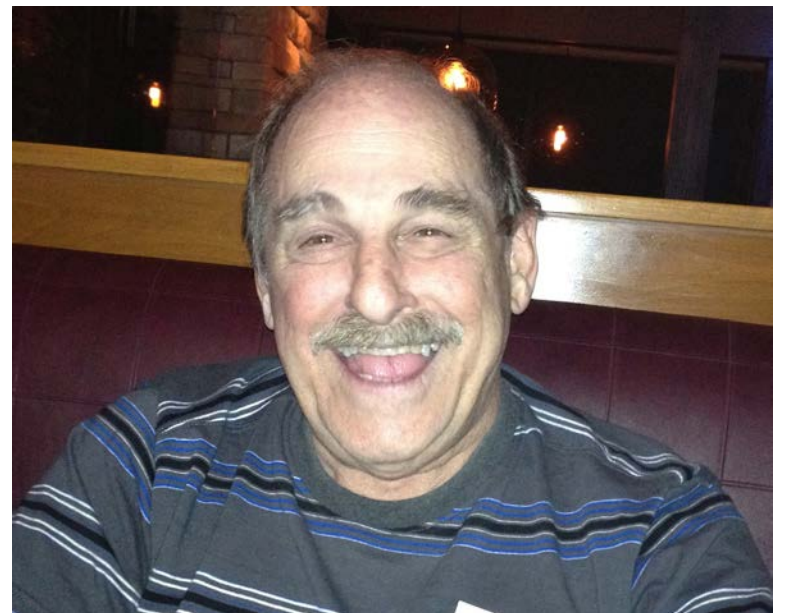

Fred Tinsley was hired by Los Angeles Philharmonic Music Director Zubin Mehta in 1974. During his 42-year tenure, he also served as assistant personnel manager and as an instructor as part of the orchestra's training program for minority students in the late 1970s and early 1980s.

Prior to joining the Los Angeles Philharmonic Tinsley was a substitute musician for the New York Philharmonic, but he began his professional music career with the Hartford Symphony Orchestra, of which he was a member from 1969 to 1974. Tinsley also served as assistant principal bassist of the New Haven Symphony Orchestra from 1971 to 1974.

Tinsley grew up in Hartford, Connecticut, attending local schools and graduating from Weaver High School. He went on to obtain a Bachelor of Fine Arts in Music from the University of Connecticut, where he was principal bassist of the university's symphony. Tinsley also studied under Bertram Turetsky at Hartt College of Music in Bloomfield, Conn. Other former teachers include John Schaeffer of the New York Philharmonic and Bill Rhein of the Boston Symphony Orchestra. In 1993, Tinsley received a Master of Music degree in Performance from the University of Redlands.

A member of the Society of PHI KAPPA LAMBDA, Tinsley served as a string bass instructor and chamber music coach at a number of institutions, including Pomona College, University of Redlands, California Institute of the Arts, and the University of Connecticut. He was also the recipient of the University of Connecticut School of Fine Arts Alumni Award for 2010.

Tinsley was also a true jazz aficionado, having worked with several noted jazz musicians, including: Blue Note recording artist Johnny "Hammond" Smith, Academy Award nominee Dexter Gordon, trumpeter Freddie Hubbard, guitarist Kenny Burrell, tenor saxophonists Jimmy Heath and Houston Person, and award-winning flutist James Newton.

The Los Angeles Philharmonic will dedicate a concert to Fred Tinsley's memory at Walt Disney Concert Hall during the opening week of concerts with a piece selected to honor his life and work.

2017 Health and Life Insurance Eligibility

Eligibility & Enrollment Information

Eligibility and Enrollment information will be mailed to eligible participants in approximately mid-November. Enrollment materials will be sent to the participant’s last address on file with the Fund’s Administrative Office, so please ensure that the Fund has your most up-to-date address information.

The enrollment materials will advise the eligible participant at which Level of coverage they have qualified (A, B or C), based on employer contributions the Fund received on the participant’s behalf for employment between Oct. 3, 2015, and Oct. 2, 2016. Benefit summaries and co-premium costs for the applicable Level will also be included in the enrollment material.

Effective January 1, 2017, eligible participants that qualify at Level B will also have the option of enrolling in Blue Shield.

The qualifying Levels and available benefits are as follows:

Again, and in order to be covered by one of the Fund’s benefit plans, for the coverage year beginning Jan. 1, 2017, you must (A) have accumulated a minimum of \$800 in employer contributions, for work performed Oct. 3, 2015 through Oct. 2, 2016, and (B) complete and return, to the Fund’s Administrative Office, the applicable enrollment form, along with the proper co-premium no later than Dec. 20, 2016.

Life Insurance Coverage For All Eligible Participants

A life insurance benefit of \$20,000 is also provided by the Fund to all eligible participants. **Enrollment in one of the Fund’s medical plans is not required.** Information regarding the Fund’s life insurance benefit shall be included in the annual enrollment materials/package.

All eligible participants are covered under the Fund’s life insurance benefit. Even if you choose not to enroll in one of the Fund’s medical plans, you may complete the life insurance beneficiary form; return the completed form to the Fund’s administrative office:

"Instead of riding it out and dealing with more industry damage, I believe it is time for artists to take control of their credits, identity, metadata, and digital legacy," says Christy Crowl, Founder of ProMusicDB.org and a successful songwriter, singer, musician, producer and music director. "We need to build a central resource of professional music credits and metadata online, and that data should be reusable to conduct our business and preserve our collective legacy."

Through ProMusicDB.org's easy-to-use Digital Musician Companion™ template tool, members only need to input their basic information once, then can begin adding their credits and metadata to their personal ProMusicDB archive. With a ProMusicDB.org URL, members can save their name and will be assigned a Unique Global Identifier to protect and validate their identity. In addition, ProMusicDB.org is offering personal credits/data curation services, enabling artists to clean up incorrect data about them in open source and proprietary databases.

Through ProMusicDB.org, commercial interests of the music industry can correctly identify and locate music professionals, helping the industry become more transparent and benefiting the economy of musicians and their professional organizations. In addition, academic and government interests (including the Library of Congress, U.S. Copyright office, and universities) can enhance their catalogs with authenticated creator, rights and performer information, or contribute their stored data to an authentic metadata ecosystem. This benefits music students, rights holders, their colleagues, and music fans who are looking for one place to discover musical facts.

"The artists have already done the hard work—creating music. Now we have a platform where they can validate their identity and preserve their credits and archives in a centralized manner, and have created the infrastructure that can benefit both artists and industry when they need to access and repurpose that information," Crowl adds. "We hope both the professional musician and performing rights organizations, as well as music and music credit retailers, will work with us to make their systems more interoperable with ProMusicDB, for the benefit of their members and customers. Over the long term, we believe that the basics of who wrote, played, produced, or participated in the creation of a musical work needs to be easily accessible – from the marketing aspect for the professional musician/music creator, to the end-user satisfaction of curiosity to know who wrote and played on a song or score that is being listened to. Ultimately, I believe it's how the next generation of musicians, and many after, will learn about being a musician. And as our music products are everywhere, the information about who created those music products should be too."

ProMusicDB.org is a project of the Pasadena Arts Council's EMERGE Program and is a founding member of the BerkleelCE Open Music Initiative. Endorsers include the Professional Musicians Local 47 of the American Federation of Musicians, SAG-AFTRA Singers, the Music Library Association, the Entertainment ID Registry Association, and the Wrecking Crew.

Suspension/Expulsion

Annual and Semi-Annual Membership Dues, due Jan. 1 of each year, must be received by March 31 (three-month grace period) to avoid suspension. If not paid by this date, a reinstatement fee will be assessed. Both dues and reinstatement fee must be paid by June 30 to avoid expulsion. Likewise, Semi-Annual Membership Dues for Regular Members, due July 1, must be received by Sept. 30 (three-month grace period) to avoid suspension. If not paid by this date, a reinstatement fee will be assessed. Both dues and reinstatement fee must be paid by Dec. 31 to avoid expulsion.

Reinstatement

A member suspended for non-payment of Periodic Dues shall be restored to membership in good standing upon payment of a \$75 reinstatement fee together with all accrued indebtedness to the Local and the then current semi-annual Periodic Dues. A former member expelled for non-payment of Periodic Dues who applies for reinstatement within one year from the date of suspension shall be restored to membership in good standing upon payment of a \$75 reinstatement fee together with all indebtedness to the Local accrued until the time of expulsion, and the then current semi-annual Periodic Dues. Please Note the Following Important Information:

If your membership dues are received by the Local after MARCH 31 (annual or semi-annual payments) or SEPT. 30 (semi-annual payments only), your membership dues payment will be subject to a reinstatement fee and will be allocated as follows:

Multiple-Card AFM Member Rebate

According to Article 8, Section 7(a)(ii) of the AFM Bylaws, the rebate is only available to members who held simultaneous memberships in three or more Locals for the full calendar year. Members will not be given rebates for dual memberships.

Under the rebate program, membership in a base of two Locals must be established in order for a member to qualify for a rebate. The International Secretary/Treasurer's office has determined that a musician's membership in his or her "Home Local" and the subsequent Local of longest tenure shall be designated as the two base Locals. The Secretary/Treasurer's office will then rebate the appropriate per capita dues for membership in the third Local and any other Local(s) beyond three to which a member belonged for the entire previous calendar year.

To petition for a Multiple-Card Member Rebate, members should fill out the form and return it to the Secretary/Treasurer's office together with copies of all their paid-up membership cards, receipts of canceled checks for annual dues from all Locals, or a letter from each Local stating that the petitioner was a member in good standing of the Locals for the full year prior.

No rebates will be issued until the Secretary/Treasurer's office verifies that petitioning members held continuous membership and per capita dues have been paid in three or more Locals for the full prior year. Rebates will be issued after Jan. 1.
