### **Officer Reports**

President Stephanie O'Keefe



When people ask me how I like being President of Local

47, I answer that I love it — because all day long, I participate in two of my favorite activities, talking to people and solving problems.

Who do I talk to?

- Members who have questions about their employment and the agreements that cover their work
- Contractors seeking assistance or clarification in executing agreements
- Employers with questions about wages, benefits, and other terms and conditions of our collective bargaining agreements

- Officers from other Locals, sharing or seeking out information
- Local 47 staff, seeking assistance or resources to assist them in their positions
- Human Resources, reporting daily on any personnel issues
- Trustees and administrators of the Musicians Health and Welfare Trust, working to continue the health insurance programs vital to many members
- Affiliates and Staff of the LA County Federation of Labor, with whom the Local works in solidarity on many organized labor issues
- Local 47 Counsel, regarding current negotiations and other legal issues
- Non-members, asking about joining the AFM
- Members and employers needing information about Covid protocols for safely returning to work

What are some of the problems?

- Members waiting too long for their questions to be answered
- Members needing assistance with dues statements and payments
- Members concerned about Covid and returning to work safely
- Big bands and orchestras needing a place to rehearse
- Incorrect payment for jobs, both live and recording
- Wages frozen as contracts were extended during Covid
- Members' concerns about health insurance and qualifying

What are some of the solutions?

- Over 30 collective bargaining agreements, with wage and benefit increases, signed
- Four employers new to the AFM, each signed to their own collective bargaining agreement
- Rehearsal rooms opened safely
- The inauguration of the Captain Greg Welch Gathering Place, a space large enough for orchestra rehearsals and large meetings
- Membership Department managed by knowledgeable, caring personnel
- A fully staffed, well trained and highly responsive Electronic Media Division
- Thousands of dollars in underpaid wages for remote recording collected and distributed to musicians
- Additional staff hired to process contracts and wages
- Additional staff hired in Live Performance, so that issues can be handled and questions fielded more quickly

We continue to work as fast and as hard as we can to bring to you, the members of Local 47, the Local you deserve to have; a Local that will support you and assist you as you go about the business of bringing music to the world.

### Vice President Marc Sazer

Visitors to Local 47 in Burbank will quickly notice some dramatic changes downstairs. The new, large and airy meeting space is now ready for its close-up!



Room for a 50+ piece orchestra, a new water fountain and water bottle filling station and plenty of scheduling opportunities make for a great new resource. And finally, we now have space for a full General Membership Meeting without being squeezed into a rehearsal room.

One year. That's how long our computer programmer and his small team have been working on our new database, Ensemble 2, and progress continues apace. Many comparable development projects take years, and previous computer system makeovers right here at Local 47 have taken much longer, but we are on track for completion of E2 this year. We have been keeping the Executive Board abreast of the occasional starts and stops, and also the forward progress.

Our commitment to education and transparency with our media contracts now extends up and down the line. Our new Federation Electronic Media Services Director John Painting has been working on a comprehensive series of "toolkits" for each of our contracts, and we have been consulting and helping in their development. Once these are rolled out to the public they should give you and your colleagues clear and easy access to each contract, rules and wages, complete with paperwork and forms included.

Part of our effort means moving forward with site visits by our Local 47 Business Representatives. Don't be surprised if you see 47 EMD Director Rebecca Gurnee, or Sound Recording Rep Jamie Vespa, or Videotape Rep Russell Winkler at a session — say hello, and get to know them. They are your direct line to real information and assistance.

We have been working steadily and passionately on the problem of late payments for studio musicians. Our film and TV contracts lay out three steps; first, it is the responsibility of the company to give Local 47 notice of the session as soon as they know about it, but at the latest, promptly after the call goes out. Then, the pay day for musicians is the same week as the work (Thursday, to be exact). Finally, late payment penalties can be assessed, but only after notifying the company of the late payment.

We have been working with the AFM to solve the breakdown in the system that leaves so many players waiting months for paychecks — even through pandemic, inflation, and runaway production.

Our efforts have led to direct talks between the Federation and the leadership of the Alliance of Motion Picture and Television Producers, and we are hoping to have concrete news to share shortly.

We continue to invest in relationships that are important to our collective interests. We meet weekly with the California Conference of AFM Locals, monthly with the Western Conference, regularly with the LA County Federation of Labor, adjacent unions, and not-so-adjacent unions.

One of our most successful bridge-building tools is the Hollywood Bowl box that Local 47 has enjoyed access to for many decades. This summer's guests include labor leaders from I.A.T.S.E., UNITE HERE and others, representatives of the AFM & SAG-AF-TRA Fund, a Pulitzer-prize winning journalist ally, and more.

We know that our outside friends can't wave magic wands on our behalf, but we also know that as long as we reach out and build powerful relationships we're not in this alone.

Business unionism/organizing unionism. All of the efforts that go on day after day at Local 47 to help the business of our union run more responsively, efficiently and effectively are critically important, and take tremendous focus, thought and energy on the part of our Officers and our dedicated and hard-working staff, from top to bottom.

What we need to keep in our sights is that this is only half the job. We need to invest just as much in helping musicians improve their contracts, campaign for public policy to improve our employment and conditions, and unionize the non-union. Our future depends on our activism.

By now, most of you will have heard about the Fair Share for Musicians campaign for an equitable residual payment when musicians work on made-forstreaming shows. The issue is clear-cut, and you can visit fairshareformusicians.org to lend your voice to the online petition in support of the campaign.

Our capacity to win is founded in our ability to achieve unity and teamwork. On August 14th, Local 47 hosted an Education Session meeting, open to all AFM members, put together by the Contract Action Team, with dinner and beverages provided by RMA-LA, a panel that included Committee chairs, AFM staff and Local 47 staff. This was a clear demonstration of our joint commitment and common purpose.

The evening featured introductory welcoming remarks by President O'Keefe, a series of PowerPoint presentations, one-pager informational handouts, and panel presentation followed by an hour-long moderated Q&A discussion.

Education is a key component of helping musicians pull together. All this began with a national survey of affected musicians at the end of last year, and continued on with musicians setting up zoom meetings and committees and a petition on their own. We have built bridges with AFM Locals in New York, Nashville, Chicago and other media centers, as well as with I.A.T.S.E. Locals, SAG-AFTRA and others. At this writing, it is unresolved whether we will be going into negotiations this November, or accepting a one year extension, negotiating in 2023. Either way, the battle for fair pay for streaming is going to be tough. We will keep you informed!

What the labor movement at large has learned, in the entertainment industry and the warehouse industry, on a scoring stage and behind a Starbucks counter, is that investing in organizing is investing in the future. Whether facing a mega-multi-billion dollar media corporation or a local theater company, the fundamentals remain; only by unity and teamwork can we move forward. Our leverage is us — we are always stronger together.

# Secretary/Treasurer Danita Ng-Poss

Eighteen months ago when I began my term as your Secretary/Treasurer, I knew it would be a challenge. I also knew that challenge would be even greater during a

pandemic we had never before experienced. I accepted these challenges; and I am proud to have met them head-on, and made significant improvements in how our local operates. Some of the results are internal and may be difficult for members to see. However, I hope many of you have noticed that your local has been more responsive to your membership needs since I have taken office.

Building a new system is difficult and slow. One of the keys to guarantee results is investing in the right people. Our administration prioritized finding the right people to help rebuild Local 47 as one of our first steps. We need people willing to dedicate themselves to making the change together with us. We know improving our Local is a team effort.

Local 47's new and rebuilt Membership Department is only eight months old. The amount of work the Membership Department has done, and continues to do, is immeasurable. Our current Membership Department staff consists of one full-time and one parttime person serving over 5,000 members. That is a ratio of about one staff person for every 3,333 members. Think about the challenge of those numbers. That is why I am so proud of our Membership Department and the improvements we have made responding to your needs during the last 8 months. We have achieved these improvements during a time of great challenge to the health of our local, and a time when we needed to be more careful than ever with our money.

Our rebuilding in Membership and other areas continues, and there is still much to do. There are other projects my office aims to complete before the end of 2022. Together with your help, we will continue delivering the improvements and transparency for which you voted for nearly two years ago.




### New Name, New Look, Same Mission

The Actors Fund, a national human services organization for everyone in performing arts and entertainment, has changed their name to Entertainment Community Fund, in order to better reflect the broad scope of industry professionals they help.

Since its founding in 1882, the organization has served everyone on the stage and on the screen, in the pit and in the studio, behind the camera and behind the scenes with the specific goal of helping all industry professionals support a life in the arts.

"It's a new name and a new look, with the same mission," said Fund chairman Brian Stokes Mitchell. "We recognize the dedication of technicians, camera operators, stagehands, writers, musicians, stage managers, actors and thousands more who work in film, television, radio, music, theater, dance and opera. They all contribute to our country's cultural vibrancy. We value them. We support them. And the Fund is here for all of them."



"If you are doing stand-up in Chicago or music videos in Atlanta, you need to know the Entertainment Community Fund is here for you," said five-time Emmy nominee and Fund trustee Chandra Wilson. "Performing arts and entertainment are a fundamental part of every community, large and small, throughout the country, and the Fund is here to help people in that space regardless of what they do. We recognize that it can be uniquely challenging to sustain a life in the arts. It is why we come together as a community to help each other."

The Entertainment Community Fund has been the only organization, with reach from coast to coast, committed to helping all of those who work in entertainment and the performing arts, in every aspect over their lifespan and throughout the entire course of their careers. The organization provides holistic support to assist members of the entertainment community with the unique hardships of working in the industry and lift them up when crises hit – like when the COVID-19 pandemic shut down the entire performing arts and entertainment industry in March of 2020.

The pandemic has had a tremendous impact on workers in the entertainment industry. Amid these dire conditions, the Fund scaled up its operations to fulfill its mission of fostering stability and resilience. In 2020 and 2021, the organization served more than 60,000 individuals through a wide range of programs and services focusing on health and wellness, career and life, and financial wellness (a 68% increase over the preceding two non-pandemic years). Since March of 2020, the Fund has distributed more than \$26.8 million in emergency financial assistance to some 17,900 individuals.

Working from coast to coast, the Entertainment Community Fund has local offices in Los Angeles, Chicago and New York. AFM Local 47 President Stephanie O'Keefe is among the Western Council's board members, whose mission is to increase financial support and develop fundraising efforts in the Western Region, advise the Board of Trustees regarding the needs of the community, and help spread the word about the organization's programs and services.

Partners in the entertainment space, including unions and other non-profit organizations, praised the name change, noting that while actors are a critical piece of the organization and were among the founding members, the Fund has long worked to help numerous professions throughout the industry.

### **Member Spotlight: Greg Phillinganes**

AFM Local 47 Life Member Greg Phillinganes began playing a neighbor's piano by ear at the age of 2, beginning lessons a few years later after his mother purchased a piano for him. He began performing with bands around his hometown of Detroit as a teenager and was discovered by Stevie Wonder after drummer Ricky Lawson gave Stevie a demo cassette tape of his original music.

The year 1978 began his three-decade-long involvement with Michael Jackson and the Jacksons. Phillinganes contributed to every one of Michael Jackson's solo albums and cites the title track from 1982's "Thriller" as a classic example of his work.

Amidst his solo recordings and touring with Eric Clapton throughout the 1980s and the early 1990s, Phillinganes became well known as a prominent session musician for a multitude of different artists, performing on many hit albums of the time, working and touring with the likes of Donna Summer, the Bee Gees, Paul McCartney, and Aretha Franklin. His session work continues into the present.

Phillinganes won a 2015 Creative Arts Emmy Award for Outstanding Music Direction for his role as musical director for the television special "Stevie Wonder: Songs in the Key of Life," and was the music director for the 2016 Grammy Awards.

In 2021, Phillinganes added his distinct dreamy '80s synths to John Mayer's ballad version of "Last Train Home" (recorded live and in one take), pulling out some dreamy pads to back up Mayer's guitar histrionics. Check out the video here.

### AFM Local 47 2022 Triennial General Election Nominating Petitions Due September 15, Election Day December 13

The next General Election for the AFM Local 47 Executive Board, Hearing Board, and AFM Convention Delegates takes place on Tuesday, December 13, 2022. Nominations will be called for: President (1), Vice President (1), Secretary/Treasurer (1), Trustees (3), Directors (6), Hearing Board (7), AFM Convention Delegates (3), First Alternate Delegate (1), and Second Alternate Delegate (1).

To review the Local 47 Bylaws, you may access them in the members-only section of the Local 47 website, <u>afm47.org/user/login</u> (click the "Scales & Documents" tab), or contact the Secretary/Treasurer's Office at 323.993.3159 to request a hard copy.

Should you have any questions about the election please contact a member of the Election Board. Only members of the Election Board — no Local 47 officers or staff members — are authorized to answer any questions concerning the election.

In order to ensure your eligibility to vote, please be sure your membership is in good standing well in advance of payment due dates! Semi-Annual Membership Dues are due **July 1, 2022**, and must be paid by **September 30, 2022** (within the 90-day grace period) to avoid suspension. Members with Work Dues delinquencies in excess of \$500 have 30 days following the date of the Executive Board meeting at which hearing action is taken to avoid suspension. Dues may be paid online at <u>afm47.org/dues</u> or by calling 323.993.3116.

### **Eligibility for Office**

To be nominated for any office a member must have been in continuous good standing for a period of 365 calendar days immediately preceding **October 1** in any election year. To hold any office, a member must have been in continuous good standing for the period of 365 days immediately preceding the scheduled date of installation of office at the Inaugural Meeting on January 9, 2023. It is possible that a member may have been suspended during the prior 365 days and not know — for example, late payment of dues. No member shall hold nor accept nomination for more than one office, although they may additionally accept nomination for and hold the position of Delegate or Alternate Delegate. However, members nominated for the offices of President, Vice President, or Secretary/Treasurer shall not be eligible to accept separate nomination for Delegate or Alternate Delegate. Further, candidates for President, Vice President, or Secretary/Treasurer, because those officers are automatically Delegates, shall not appear separately on the ballot as Delegate (see Bylaw Article IX, Section 2).

### Nominating Petitions Available August 1, Due September 15

Nominating petitions for the upcoming General Election are available from the Secretary/Treasurer's office as of **August 1, 2022**. To request a petition, members may fill out the Nominating Petition Request Form online at <u>afm47.org/election</u> or contact the Secretary's Office at <u>petition@afm47.org</u> or 323.993.3159. All completed nominating petitions with at least 50 signatures from members in good standing must be delivered to the Secretary's Office, in exchange for a signed and dated receipt, no later than 4:45 p.m. on **September 15, 2022**. Please do so early. Members on a slate need only file one petition. Further instructions will be provided to those who request a petition.

### **Policy Governing Eligibility to Vote**

 All Local 47 members who are in good standing as of 4:45 p.m. (close of business) on **December 12, 2022** 
 the last business day prior to the General Election
 are eligible to cast a ballot. However, members are encouraged to be in good standing well in advance of this deadline.

2. Any Local 47 member who has been suspended or expelled for the non-payment of dues, or wishing to reinstate within one year of resignation, shall have until 4:45 p.m. on **December 12, 2022** by which to clear the delinquency and return to full good-standing status in order to be eligible to cast a ballot.

3. New members, or those rejoining after having resigned or been expelled more than one year ago, must complete and submit a membership application and membership dues payment no later than **December 5, 2022** by 4:45 p.m., so that their membership can be approved at the next Local 47 Executive Board meeting the Tuesday prior to the General Election. All applicable fees apply. (Note: The Local reserves the right to refer applications of all persons seeking reinstatement from resignation to the International Executive Board per Article 9, Section 19 of the Federation's Bylaws.)

4. Life Members in good standing may vote in the Local 47 General Election. Inactive Life Members, who pay a reduced membership fee, are not eligible to vote per our Bylaws. Inactive Life Members wishing to vote may do so by changing their membership status to Life Member by contacting the Membership Department at 323.993.3116 and completing the process by 4:45 p.m. on **December 12, 2022**. All applicable fees apply.

### **Prohibited Campaigning Directive**

The use of Local 47 resources, or the resources of ANY other union or employer — whether hiring musicians or not — by any candidate or member, for the purpose of campaigning for or against any candidate for office in the Local 47 election, is prohibited by the Local's Bylaws and is also a violation of Federal Law. This prohibition includes the use of facilities, equipment or property (including telephones, stamps and stamp machines, computers, copying machines, and any other equipment or materials), official endorsements, use of union logos and/or letterhead, and any campaign activity done on paid time. Additionally, members are barred by Article IX, Section 13 of the Local 47 Bylaws from collecting nominating petition signatures while on Local 47's premises. Further, members are prohibited from campaigning at any time while on Local 47's premises

However, obtaining signatures on public property (i.e., sidewalks surrounding the Local's property or off-site locations) IS permissible, as long as those collecting signatures and the members are using unpaid time (e.g., before or after work for any union or employer, or while on an unpaid break). Nothing in the Bylaws prohibits friends/family of a candidate from soliciting signatures on nominating petitions provided they abide by all the rules listed above.

### **Electronic Communications Policy**

Following the intent of Article IX, Section 12, of the AFM Local 47 Bylaws, it shall be a matter of policy that the rules and restrictions as outlined in said Bylaw shall also apply to all electronic communications published by Local 47, including Overture, the Local 47 website (afm47.org), the Local 47 email newsletter "The Local 47 Beat," any special notices sent by Local 47 via email blast, and all associated social media pages (Facebook, Twitter, Instagram, LinkedIn, etc.).

Stay tuned to further notices and refer to our election web page at <u>afm47.org/election</u> for updates about the voting process on AFM Local 47 Election Day, **December 13, 2022**. Members with an email on file will receive election updates via email, and those whose emails are not on file or who have opted out of electronic notifications will receive printed announcements by mail. ### IRS Mileage Reimbursement Rate Increase for Remainder of 2022

The IRS mileage reimbursement rate has been changed for the remainder of 2022. The new rate, in effect as of July 1 through Dec. 31, 2022, is now 62.5 cents per mile driven for business use (up from 58.5 cents per mile as of Jan. 1, 2022). The Local 47 Wage Scale book in the <u>members section</u> of our website has been updated to reflect this change.

### PROFESSIONAL MUSICIANS LOCAL 47 AND EMPLOYERS HEALTH & WELFARE FUND

The Professional Musicians Local 47 and Employers Health & Welfare Fund is administered by PacFed Benefit Administrators. AFM Local 47 negotiates benefits on behalf of our members. The Health & Welfare Trust provides medical, dental, vision, chiropractic, acupuncture, prescription drugs and life insurance to musicians who qualify for benefits based upon contributions received on their behalf in accordance with Local 47 and AFM contracts and collective bargaining agreements.

### Eligibility

Eligibility for enrollment in the Health & Welfare Fund is based upon contributions the Fund receives on musicians' behalf from Participating Employers. A Participating Employer, or an Employers' Payroll Designee, has entered into a Collective Bargaining Agreement (CBA) with the Union which calls for contributions to come to the Health & Welfare Fund. All contributions must come from a Participating Employer; musicians may not "self-pay" into the Heath & Welfare Fund.

### Coverage

A musician may qualify at one of three levels: Level A (\$1,500+ contribution), Level B (\$1,200-\$1,499 contribution), and Level C (\$700-\$1,199 contribution). Currently the Health & Welfare Fund has contracted with the following benefit providers: Blue Shield, Kaiser Permanente, Landmark Healthplan, Delta Dental, MES Vision underwritten by Gerber Life, and the Prudential Insurance Company of America ("Prudential Life"). To review the Summary Plan Description (SPD), please click here. Any questions regarding a participant or dependent's eligibility and coverage should be directed to the Health & Welfare Fund.

### **ENTERTAINMENT INDUSTRY FLEX PLAN**

The Entertainment industry Flex Plan is an employee benefit plan which combines both Employer Contributions and Employee Contributions to fund benefits including medical, dental, vision, disability, group term life insurance, and dependent care assistance for union members working in Motion Picture and Television. The Flex Plan was established in 1985 to provide Health and related benefits for "Daily-Hire" Union employees working under Collective Bargaining Agreements in the Entertainment Industry.

### Eligibility

The Flex Plan covers each person who is employed by an Employer who has entered into a Collective Bargaining Agreement (CBA) with a Local Union providing for Employer Contributions to the Flex Plan. If you are unsure if a specific employer participates in the Flex Plan, contact the Flex Plan. For a complete summary of benefits and information on Employer contributions and Employee contributions, view the Flex Plan Summary Plan Description (SPD).

### Coverage

The Plan offers a flexible "cafeteria style" benefit option list in which you design your individual plan according to your needs. If you elect coverage from the Flex Plan Providers, the Flex Plan will make monthly premium payments on your behalf to the carrier(s) you select (provided your account balance is sufficient to pay all of the premiums). Please refer to the Flex Plan Summary of Benefits for descriptions and monthly costs of the coverages offered. If you do not have sufficient funds in your account to pay your premiums, the Flex Plan allows you to "self-pay" the necessary premiums for a period of 12 months.

### AMERICAN FEDERATION OF MUSICIANS & EMPLOYERS' PENSION FUND (AFM-EPF)

One of the most important benefits your job provides you with is the ability to receive pension benefits when you retire. Even though you can collect Social Security at retirement, your retirement years will be more financially secure if you also receive pension benefits. The American Federation of Musicians and Employers' Pension Fund (AFM-EPF) is a defined benefit multi-employer pension plan for members of

the American Federation of Musicians.

Under a collective bargaining agreement with the AFM and its Local unions, or other written agreement acceptable to the Board of Trustees, your employer has agreed to make contributions to a pension fund to provide pension benefits to you and other employees working as musicians. The Pension Fund is operated by the AFM-EPF Board of Trustees, which consists of an equal number of Federation Trustees and Employer Trustees.

You should keep in mind that you are not guaranteed a pension just because a pension fund has been established to which your employer contributes. The Pension Fund has rules about how you begin to participate, how can you earn a right to your pension, how much you might receive and when you can start getting payments, what happens to your pension if you die before or after retirement, and many other issues. ### **Terry Harrington** Life Member. Alto/Tenor Saxophone 7/27/1938 - 7/20/2022

Terry Harrington passed away on July 20, 2022, after a week in hospice care. A heart transplant in December 2001 allowed him to fulfill all his personal and professional ambitions.

Terry was born in Detroit, Michigan, on July 27, 1938, and met the love of his life, Ellen, when he was 13. As a boy, Terry loved baseball and music. He pitched a no-hitter at Briggs Stadium in the 1956 Michigan State Championship game. Terry was also an accomplished woodwind musician, ultimately becoming his chosen profession. Terry and Ellen married on August 20, 1960, and he graduated from Wayne State University in 1963. The family is grateful that he had 20 years and seven months with his transplanted heart, a gift of life that allowed him to enjoy countless memories, including the birth of five grandchildren and one great-grandchild. Terry is survived by his wife of 61 years, Ellen Jonsson Harrington, children Kevin Harrington (Kathy) and Kim Clayton (Robert), grandchildren Christopher Troike, Megan Trotter (Miles), Kelley Harrington, Tom Harrington, and Steven Clayton, and great-granddaughter, Lily Trotter.

Terry enjoyed an illustrious 65-year career in the music industry. He performed and recorded with most Motown artists in the 60s and was the musical director and band leader at the famous Roostertail on the Detroit River, supporting the greatest entertainers in America. Early in his life, he was a staff musician at WJR (CBS) Radio, doing daily shows.

In 1969, the family followed Motown's move to Los Angeles. Terry became a highly sought-after studio musician doing TV, movie, and live performance work in Hollywood, L.A., and Las Vegas. He was an extraordinary jazz artist and published a highly acclaimed book on advanced jazz improvisation and polytonality called "The Way I See It." In 1997, Terry released a Grammy-nominated jazz album, "Comin' Atcha." He was also a Screen Actors Guild (SAG/AFTRA) member and played roles on "Days of Our Lives" and "Modern Family." However, his most famous role was being the longtime baritone saxophone voice of Lisa Simpson on the Fox TV show, "The Simpsons." "The Simpsons" show (now Disney) recently honored Terry's contributions in the closing credits by giving him his own Simpson character likeness.

A private memorial service will take place in October 2022. Memorial donations are welcome in Terry's name to <u>Mr. Holland's Opus Foundation</u>, <u>One Legacy</u>, or the <u>American Heart Association</u>.

### Mike Lang

Life Member. Piano 12/10/1941 - 8/5/2022

Mike Lang, one of the preeminent pianists in Hollywood history, died of lung cancer August 5 at his home in Studio City. He was 80.

Lang played piano (or organ, harpsichord or celeste) on an estimated 2,000 film and TV scores dating back to the mid-1960s, including scores by virtually every great film composer of the past 50 years: John Williams ("Close Encounters of the Third Kind," "Catch Me If You Can"), Jerry Goldsmith ("Gremlins," "The Russia House"), John Barry ("Body Heat," "The Specialist"), Henry Mancini ("10"), Alex North ("The Shoes of the Fisherman"), Elmer Bernstein ("The Rainmaker"), Miklós Rózsa ("Dead Men Don't Wear Plaid") and many others.

### **Dues Schedule**

Annual and Semi-Annual Membership Dues for Regular, Life and Inactive Life Members are due Jan. 1 of each year. Payment must be received by March 31 (three-month grace period) to avoid suspension. If not paid by this date, a \$75 reinstatement fee will be assessed. Payment must be paid by June 30 to avoid expulsion.

Likewise, Semi-Annual Membership Dues for Regular Members are due **July 1** and must be received by **Sept. 30** (three-month grace period) to avoid suspension. If not paid by this date, a \$75 reinstatement fee will be assessed. **Payment must be paid by Dec. 31 to avoid expulsion.** 

Please note: Inactive Life Members do not have all of the same rights as privileges as Regular and Life Members, such as the right to vote in Local elections. Please review the AFM Local 47 Bylaws for complete information.

### Work Dues Notices

At its Dec. 9, 2014 meeting, the Local 47 Executive Board passed the following motion:

"As a matter of policy, Local 47 will no longer mail checks to members or non-members whose delinquent work dues liability is in excess of \$1,000. When the Local receives a payroll check for anyone who has such a delinquency, the member or non-member shall be contacted by the Secretary/Treasurer's office. Checks within 14 days of expiration will be deposited in the Escrow Fund."

If you fall into that category, you will receive a postcard informing you that your check is in the office. You can call the Secretary/Treasurer's office at (323) 993-3159 to discuss your work dues delinquency and to make arrangements to pick up your check.

### Notice From the Executive Board: Work Dues Delinquency and Suspension

1) Local 47 members whose work dues delinquency exceeds \$500 shall be suspended; and

2) Non-Local 47 members whose work dues delinquency exceeds \$500 shall be referred to the IEB as provided in the AFM Bylaws.

In order to reinstate membership, a \$75 reinstatement fee will be assessed.

### **Resignation Policy**

In order to resign in good standing, you must submit your written request to Local 47 before your membership is suspended. Though dues are due Jan. 1 and July 1, current grace periods extend to March 31 and Sept. 30, respectively; suspensions are posted April 1 and Oct. 1.

In addition to membership dues, all other financial obligations, Local and International, must be paid prior to resignation. Your letter of resignation will be presented at the following Executive Board meeting and a written response will be mailed to you. If you wait, you will be required to pay another half year's dues and/or clearance fee.

### **AFM Local 47 Refund/Return Policy**

### **Multiple-Card AFM Member Rebate**

Did you know? If you hold membership in three or

more Locals throughout a full calendar year, you are entitled to a rebate from the AFM.

Under the rebate program, membership in a base of two Locals must be established in order for a member to qualify for a rebate. The International Secretary/ Treasurer's office has determined that a musician's membership in his or her "Home Local" and the subsequent Local of longest tenure shall be designated as the two base Locals. The Secretary/Treasurer's office will then rebate the appropriate per capita dues for membership in the third Local and any other Local(s) beyond three to which a member belonged for the entire previous calendar year.

To petition for a Multiple-Card Member Rebate, members should fill out the form and return it to the Secretary/Treasurer's office together with copies of all their paid-up membership cards, receipts of canceled checks for annual dues from all Locals, or a letter from each Local stating that the petitioner was a member in good standing of the Locals for the full year prior. Rebates will be issued after Jan. 1.

Your Union will take action — with legal counsel if necessary — on your behalf to ensure your rights as a union worker are protected.
