Disability: Part of the **Equity Equation**

October is Disability Employment **Awareness Month**

In recognition of the vital role people with disabilities play in making the nation's workforce diverse and inclusive, the U.S. Department of Labor selected "Disability: Part of the Equity Equation" as the theme for October's National Disability Employment Awareness Month 2022.

Held annually, National Disability Employment

Awareness Month is led by the U.S. Department of Labor's Office of Disability Employment Policy, but its true spirit lies in the many observances held at the grassroots level across the nation every year. This annual observance acknowledges the contributions to the nation's economy made by workers with disabilities, current and past. The commemoration also showcases supportive and inclusive policies and practices benefiting workers and employers.


Lester Petrillo Memorial Fund

Member Spotlight



Member Spotlight: John Carpenter

MEMBER SINCE 1998

A master of horror, John Carpenter is an American filmmaker, actor and composer who has worked in various film genres. While most commonly associated with horror, action, and science fiction films of the 1970s and 1980se is generally recognized as one of the greatest innovators of the horror genre.

Born in Carthage, New York, Carpenter developed an interest in film and music as a young boy. After high school he enrolled at the University of Southern California, where one school project, "The Resurrection of Bronco Billy," won him an Academy Award (best live action short subject) in 1970. Carpenter co-wrote the screenplay and composed the music for the film. He enjoyed his biggest hit with 1978's "Halloween," serving as the director, co-writer and composer on what became one of the highest-earning independent films of all time.

He continues to thrill and disturb audiences, and his rank as an action director is evident in such productions as "Vampires," "Ghosts of Mars," "Escape from L.A." and "Big Trouble in Little China." His motion picture credits also include the comedy-thriller "Memoirs of an Invisible Man," the sci-fi love story "Starman," which earned Jeff Bridges a Best Actor Oscar nomination, and "Village of the Damned," the terrifying remake of the classic 1950s horror story. He won the Cable Ace Award for writing the HBO movie, "El Diablo."

Carpenter was born in Carthage, New York. His family later moved to Bowling Green, Kentucky, where his father was the head of the music department at Western Kentucky University. He attended Western Kentucky University followed by the USC School of Cinema in Los Angeles. WKU awarded him an honorary doctorate in 2007. He lives in Hollywood, California with his

wife, Sandy King, his frequent collaborator.





Film and TV Contracts Get One-Year Extension; Fair Share For Musicians Campaign Continues to Build

A Message from the Contract Action Team

The AFM Film and TV contracts were originally set to expire this November. The AFM has now agreed to a one-year extension. This is subject to ratification, which means that you will have a vote. We will hold a meeting soon about this development.

A Message from AFM International President Ray Hair

Congress has moved a step closer to ending a decades-long injustice against music creators with the recent Senate introduction of the American Music Fairness Act (AMFA). The legislation, sponsored by Senators Marsha Blackburn (R-TN) and Alex Padilla (D-CA), would require broadcast corporations to pay performance royalties to creators for AM/FM radio plays. An identical bill (HR 4130) has already been introduced and received a hearing in the House, setting Congress up for action this summer and fall. Musicians and vocalists do not receive a single cent when their recordings are broadcast on American AM/FM radio stations. Incredibly, the United States is the only industrialized nation besides North Korea and Iran that has no law requiring a broadcast performance royalty for sound recordings to be paid to artists, musicians, and singers.

The American Music Fairness Act is designed to remedy that and provide royalty payments to artists, session musicians, and vocalists when their recordings are broadcast over AM and FM radio.

This is OUR bill. The AFM worked closely with the MusicFIRST Coalition and members of Congress to help craft this bill designed with your concerns in mind as a musician.

It's time to end the loophole that has allowed Big Radio to rob artists of their fair share for far too long.

The Professional Musicians Local 47 and Employers

Health & Welfare Fund is administered by PacFed

Benefit Administrators. AFM Local 47 negotiates benefits on behalf of our members. The Health & Welfare Trust provides medical, dental, vision, chiropractic, acupuncture, prescription drugs and life insurance to musicians who qualify for benefits based upon contributions received on their behalf in accordance with Local 47 and AFM contracts and

collective bargaining agreements. Eligibility Eligibility for enrollment in the Health & Welfare

Fund is based upon contributions the Fund receives

on musicians' behalf from Participating Employers.

A Participating Employer, or an Employers' Payroll Designee, has entered into a Collective Bargaining Agreement (CBA) with the Union which calls for contributions to come to the Health & Welfare Fund. All contributions must come from a Participating Employer; musicians may not "self-pay" into the

Coverage A musician may qualify at one of three levels: Level A (\$1,500+ contribution), Level B (\$1,200-

\$1,499 contribution), and Level C (\$700-\$1,199

PENSION

AMERICAN FEDERATION OF MUSICIANS & EMPLOYERS' PENSION FUND (AFM-EPF)

One of the most important benefits your job provides you with is the ability to receive pension benefits when you retire. Even though you can collect Social Security at retirement, your retirement years will be more financially secure if you also receive pension benefits. The American Federation of Musicians and Employers' Pension Fund (AFM-EPF) is a defined benefit multi-employer pension plan for members of the American Federation of Musicians.

Under a collective bargaining agreement with the AFM and its Local unions, or other written agreement acceptable to the Board of Trustees, your employer has agreed to make contributions to a pension fund to provide pension benefits to you and other employees working as musicians. The Pension Fund is operated by the AFM-EPF Board of Trustees, which consists of an equal number of Federation Trustees and Employer Trustees.

You should keep in mind that you are not guaranteed a pension just because a pension fund has been established to which your employer contributes. The Pension Fund has rules about how you begin to participate, how can you earn a right to your pension, how much you might receive and when you can start getting payments, what happens to your pension if you die before or after retirement, and many other issues. 
