

Member Spotlight: Allen George LaMont

At 96-years-young, vocalist/composer Allen George LaMont became one of AFM Local 47's newest members when he joined the union this past August.

"I'm an old timer, and been around quite a while," he laughs, sharing that his music career began when he got out the Navy and he utilized the GI Bill, majoring in music and theater.

"I joined the union primarily for the networking opportunities," he said. LaMont is primarily a singer but says he was always surrounded by musicians, and seemed to always be looking for a piano player as an accompanist. "That's how it all started," he said. "My grandmother gave me piano lessons — whether I wanted them or not — as a child, and so that was my first instrument, the piano. But I don't brag about my piano playing. I'm a stronger singer, even though I'm kind of ancient! I'm also a composer now. I'm looking for musicians to make a demo."

He has completed a musical theater piece called "Uncle Sam" that was recently orchestrated, and is currently working on a new symphonic work.

The next General Election of the AFM Local 47 Executive Board, AFM Convention Delegates/Alternates and Hearing Board takes place Tuesday, December 13, 2022.

The alphabetical listing of nominees was published in the October 2022 issue of Overture Online and also sent to members as a postcard mailer. Starting on November 1, all eligible voters (Regular and Life Members in good standing) will be mailed a ballot, along with the Election Special Edition of Overture containing candidate statements and photos. Members are required to be sure their ballot arrives in the election post office box by 9 a.m. on the day of the election. Members are also encouraged to vote in person on election day at AFM Local 47 headquarters, 3220 Winona Ave, Burbank CA 91504. Polls will be open on Tuesday, December 13 from 9 a.m. until 9 p.m.

Prohibited Campaigning Directive

The use of Local 47 resources, or the resources of ANY

other union or employer — whether hiring musicians

or not — by any candidate or member, for the purpose

in the Local 47 election, is prohibited by the Local's Bylaws and is also a violation of Federal Law. This prohibition includes the use of facilities, equipment or property (including telephones, stamps and stamp machines, computers, copying machines, and any other equipment or materials), official endorsements,



The Professional Musicians Local 47 and Employers

Health & Welfare Fund is administered by PacFed Benefit Administrators. AFM Local 47 negotiates benefits on behalf of our members. The Health & Welfare Trust provides medical, dental, vision, chiropractic, acupuncture, prescription drugs and life insurance to musicians who qualify for benefits based upon contributions received on their behalf

in accordance with Local 47 and AFM contracts and

collective bargaining agreements. Eligibility Eligibility for enrollment in the Health & Welfare Fund is based upon contributions the Fund receives on musicians' behalf from Participating Employers. A Participating Employer, or an Employers' Payroll

Designee, has entered into a Collective Bargaining

All contributions must come from a Participating Employer; musicians may not "self-pay" into the Heath & Welfare Fund. Coverage A musician may qualify at one of three levels:

PENSION

AMERICAN FEDERATION OF MUSICIANS & EMPLOYERS' PENSION FUND (AFM-EPF)

One of the most important benefits your job provides you with is the ability to receive pension benefits when you retire. Even though you can collect Social Security at retirement, your retirement years will be more financially secure if you also receive pension benefits. The American Federation of Musicians and Employers' Pension Fund (AFM-EPF) is a defined benefit multi-employer pension plan for members of the American Federation of Musicians.

Under a collective bargaining agreement with the AFM and its Local unions, or other written agreement acceptable to the Board of Trustees, your employer has agreed to make contributions to a pension fund to provide pension benefits to you and other employees working as musicians. The Pension Fund is operated by the AFM-EPF Board of Trustees, which consists of an equal number of Federation Trustees and Employer Trustees.

You should keep in mind that you are not guaranteed a pension just because a pension fund has been established to which your employer contributes. The Pension Fund has rules about how you begin to participate, how can you earn a right to your pension, how much you might receive and when you can start getting payments, what happens to your pension if you die before or after retirement, and many other issues. Leaked Racist Remarks Rock LA City Hall, LA Fed

Los Angeles continues to reel from a leaked recorded conversation involving LA City Councilmembers Nury Martinez, Kevin de León, Gil Cedillo, and LA County Federation of Labor President Ron Herrera.

The recording captured now-former LA City Council President Martinez describing the Black son of a white council member in racist language and used offensive terms when describing Oaxacan immigrants in Koreatown, among other crude comments. Others on the recording did not object to the remarks, were heard laughing, and at times joined in the offensive banter.

Herrera resigned his post as leader of the LA Fed within days, and executive board chair Thom Davis is now serving as interim president until a special election can be held to permanently fill the vacancy. Martinez first took a leave of absence before officially resigning from the council. Both de León and Cedillo are refusing demands to step down despite widespread condemnation from many Angelenos as well as top officials, including President Biden. The council has moved to censure the two, but doesn't have the power to remove fellow elected officials from office unless they've been charged with a crime.

election in the case of de León, whose term ends in 2024. Cedillo lost his seat in the primary and will be replaced in December.

Local 47 issued the following statement immediately upon learning of the shocking events:

Acting Council President Mitch O'Farrell said the only

path forward is through their resignation or a recall

"The Executive Board of American Federation of Musicians Local 47 condemns the appalling anti-Black, anti-Indigenous, homophobic comments made during a meeting of now-former Los Angeles City Council President Nury Martinez, Councilmembers Gil Cedillo and Kevin de León, and now-former Los Angeles County Federation of Labor President Ron Herrera.

"The hateful language used during this meeting, held

within the walls of the House of Labor, was entirely unacceptable, as was the very nature of the meeting itself — scheming to disenfranchise Black and Asian voters by way of redistricting, the practice of which is deeply rooted in racial discrimination. These are not the values of the labor movement, nor are they the values of Angelenos. The only way forward is to demand accountability and swift action in the face of racism, homophobia, and bigotry, and to work for inclusion and solidarity.

"Herrera's resignation from the labor federation was

"Herrera's resignation from the labor federation was wholly appropriate, and the continued presence of these three Los Angeles City Council members will only serve to create further division and pain in our already hurting communities. AFM Local 47 demands the immediate resignation of Cedillo, de León and Martinez, whose sentiments do not represent the residents of Los Angeles and the ever-growing and powerful labor movement."


